## TREASURER'S REPORT

#### **DIRECTOR'S REPORT**

- A 0.5% annual increase in member library support has been suggested for 2026 and 2027.
- This will increase our payment by a total of \$201 over the two years, bringing the amount to \$3,818 in 2026 and \$4,019 in 2027.

This adjustment is based on factors including population, material expenditures, the three-year average (2022–2024), and the number of cardholders.

#### • Correction from Last Month's Meeting:

It was not the compressor switch that needed replacement, but the compressor itself. The electrician has shut off power to the unit, and Encore is scheduled to replace the compressor in the coming weeks.

- There have been ongoing issues with vehicles parking in the first 3 spots near the gate, which prevents the gate from closing properly at night.

  The Director proposed installing a removable pole with a lockable chain to block access to that area during off hours.
- The new furniture for the Children's Room has been delivered and installed.
- The 40th Annual Legislative Breakfast will take place on Friday, October 3 at 8:30 AM at NLS.

Trustee Basics Training will be held in person on Saturday, September 20 from 10:00 AM to 12:00 PM at NLS.

A continental breakfast will be provided. Participation fulfills the required two hours of annual trustee training.
